These are not for loan and MUST REMAIN IN THE SHOWROOM AT ALL TIMES. In extreme cases, a showroom hanger unit or wallpaper book will be loaned out for 48 HOURS. If not returned your account will be charged.

Cuttings for approval & reserves

CFA's & Reserves are only held for a short time. The time frame starts the day you place the order, not the day you actually receive it. They may expire and a new order will need to be placed. We are not responsible for stock or dye lot of your CFA. WE ARE NOT RESPOSIBLE FOR CONTINUAL FOLLOW-UPS OF YOUR CFA'S & RESERVES.

CFA's are available for dye-lot confirmations for firm orders. Please do not use a CFA to reserve fabrics on a pending order. That is what reserves are for.

Returns

All returns must be authorized by showroom management. Merchandise cannot be returned after it has been cut. All merchandise must be inspected for flaws, correctness of color, pattern, quantity and quality upon arrival and before cutting. There will be a 35% RESTOCKING FEE, PLUS SHIPPING, on all goods returned due to overage, canceled orders or mistakes on your part. Returns over 30 days will be left to the discretion of Karen Saks. After 6 weeks, there will be no returns due to overage, canceled, or your mistakes. Credits associated with returns, cancellation, overpayment, etc. will be applied to your account. WE DO NOT ISSUE CASH, CHECK, OR CREDIT CARD REFUNDS. Credits on account can only be used on orders that are billed by Karen Saks Showroom...they cannot be used on direct acct orders.
